12. **REGULAR UPDATES:**

Reports from Paul Salmon

- **TOWN CENTRE DECLUTTERING:**

A survey of street furniture requirements has been completed and the results were received today. Paul Salmon will be circulating copies of the plans which detail these requirements. Once approved by Council, CBC will place an order for the work to hopefully commence with a timescale of June 2019.

- **PARKING**

A review is underway of all parking changes. Once CBC are in receipt of the results the work will be amalgamated into one parking package.

- **GROWTH AND REGENERATION**

Update email from Ingrid Hooley covered below

- **HIGHWAYS MAINTENANCE**

Lining work at: Shortmead Street, Sun Street, Lawrence Road, Fairfield Road, etc.

An order was placed on 8th May to cover this maintenance work and the contractor is working round the clock to complete. It was noted that even with the extra 2mtrs requested at Lawrence Road, this will not solve the problem.

- **PEDESTRIAN CROSSING LONDON ROAD:**

This is hugely delayed due to Ringway Jacob target costs. CBC are progressing this backlog and will have more information by 14 June. It was requested that the signs stating that work will commence on 24 April are removed as they are confusing.

- **SIGNAGE – TOWN CENTRE CAR PARKS**

There is a need for more car park signage showing additional information such as spaces and availability for the town car parks. This is currently being discussed. Additional Bus Lane signage is also required.

- **ADDITIONAL ITEMS:**

- The Parking Report for Long Term Parking has been discussed at CBC but has not moved forward. Cllr Watkins will take this up with Cllr Young.
- Can the situation regarding Lorries/deliveries unloading on the High Street at Wetherspoons be addressed. Previous arrangements to unload at the back of Wetherspoons seem to have been overlooked, and this is causing considerable and unacceptable delays to traffic on the High Street.
- Can we consider a “No Loading” enforcement if this request is not complied with?

ADDITIONAL ITEM FOR REGULAR UPDATE:

Regeneration and HIF Bid: Ingrid Hooley has sent an email update which was relayed by Sara Hughes. Discussions are positive We are in the first tranche of assessment which goes to the investment panel in early July.
